(2) In the case of corporate body, representative status of the signatory on behalf of the corporate body should be indicated.

(3) The expression 'Member of family' means a wife, husband, father, mother, grand-father, grand-mother, step-father, step-mother, son, daughter, step-son, step-daughter, grand-son, grand-daughter, brother, sister, and wife of brother

(2) List of persons who have contributed to the share capital together with the amount contributed by each of them and the entrance fee to be paid by them.

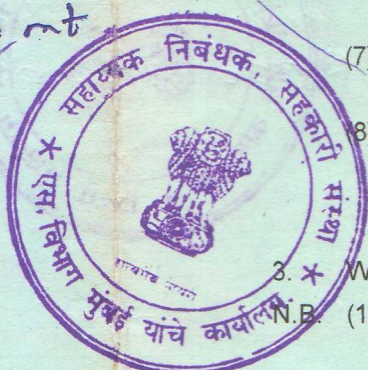


